Dust may be generated during cutting, drilling and polishing.

· **General protective and hygienic measures:**

The usual precautionary measures are to be adhered to when handling chemicals.  
 Do not breathe dust  
 Do not eat or drink while working.  
 Wash hands before breaks and at the end of work.

· **Respiratory protection:**

During dust-raising work: Use respiratory equipment with particle filter, type P2. The use of filtering respirators should be limited to max. 3 hours per day.

· **Hand protection**

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.  
 Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation

· **Material of gloves**

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.

· **Penetration time of glove material**

The exact break through time has to be found out by the manufacturer of the protective gloves and has to be observed.
